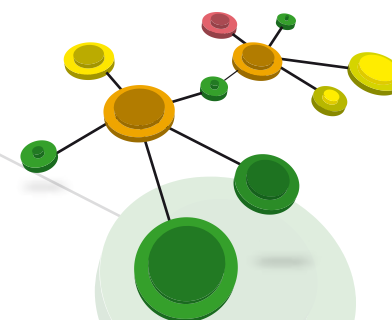

### AIMS
